






CB AUDIT THROUGH SAMPLING OF MEMBERS

 Decrease in audit costs per unit (min 10)





GROUP CERTIFICATION PROCESS






GROUP CERTIFICATION MODEL







The Group Manager can issue sanctions against the Members, including **exclusion**




Depending on the CB Audit Risk

- Define a simplified GSTC standard for Small and Low Risk Enterprises
- Common guidelines to define Audit Risk

- The certificate withdrawal should happen only in extreme cases
